**Subject:** Funds Available to Southern California Nurses to Pay ICSNC Conference Registration Fee

In support of Christian Science nurses working in Southern California, the Christian Science Nursing Care Endowment (CSNCE) will cover the registration fee for the upcoming International Christian Science Nursing Conference (ICSNC) taking place September 9 – 12, 2015 at CedarS Camps, in Lebanon, Missouri. Each eligible Christian Science nurse will have their conference fee paid directly to the conference organizers up to \$300 per attendee.

#### Conference fee payment eligibility:

- Individual must be currently living and working in Southern California as a Christian Science Nurse. Southern California is defined by the zip code range of 90000 – 93599.
- For this Conference, it is not required that a nurse be *Journal*-listed or working at a nursing facility.
- The Endowment will not pay for travel, hotel, food, entertainment, or tour costs.

#### To be credited the registration fee up front:

- Send/mail your ICSNC registration form minus the registration payment and indicate that you live in Southern California (within the specified zip code area above) and are eligible for the CSNCE registration fee reimbursement.

#### Or

- Sign up on-line at the CSNN website indicating you will pay by check. Then, send an email to: [Board@csnnetwork.org](mailto:Board@csnnetwork.org) telling them you have registered on-line. Give your name and address including zip code and write a note that you have registered on-line and CSNCE is paying your conference fee.

If you have already pre-paid your registration fee, let the Christian Science Nursing Network know about this offer at [Board@csnnetwork.org](mailto:Board@csnnetwork.org) and that you meet the eligibility requirements and they will take care of the refund for you.
